### Minutes of Meeting - February 23, 2022

#### **Chair's Welcome and Introductions**

William Sullivan welcomed everyone to the meeting and asked members of the Commission to introduce themselves.

#### **Appointment with Portman Industrial RE: Intel**

Mike Wutsbaugh of Portman Industrial Group introduced himself and provided an overview of the proposed redevelopment of the Intel site, which entails the demolition of the existing buildings and construction of an approximately 1,285,000 square foot warehouse. Mr. Wutsbaugh emphasized that they do not have the name of the tenant and that they are planning for the highest impact use of the site. He noted that the only local permitting required is Site Plan Review approval from the Planning Board. Members of the Commission expressed curiosity about the logistics operations of large-scale warehouse, and Mr. Wutsbaugh provided a general overview of how trucks load and load cargo for drop off and deliveries.
