Budget Message, Financial Planning Documents, Budget Summary

The Committee reviewed the FY25 Budget Summary and discussed the outlook for future years. In FY 25 state aid is a net 10,000 increase and education aid is a net decrease.

FY25 Hearings for Annual Town Meeting May 6, 2024

The following Articles in *FY25 Annual Town Meeting Warrant* were discussed and voted by the Committee

Article clarification notes:

Article 26 - every 3rd year additional treatment is done in the lake. This is a 3rd year so the cost is higher than in other years. Mr. Beaudette recommended exploring a collaboration with Fort Meadow water management in Marlborough to see if that would result in reduced cost. The state owns Lake Boon. The Lake Boon Commission is responsible for lake maintenance,

Article 36 - Addictions Referral Center (ARC) was established in 1972. The town started making contributions in the 1990s. The current \$20,000 funding level was set in 2010. ARC has 2 part time employees; other staffing is all volunteer. The total ARC budget is \$120,000 raised through grants,
