### **PROCEDURAL ORDER**

Pursuant to the Prehearing Report and Order issued on December 24, 2025, the deadline for any petitions to Intervene or Participate in the Public Hearing, pursuant to 310 CMR 16.20(9), to be submitted to the Board of Health (the “Board”) is on or before January 27, 2026.

The Board has received several requests for an extension of the deadline to submit petitions to Intervene. In light of the weather conditions occurring over the weekend and on Monday, January 26<sup>th</sup>, proposed Ten Citizen Groups seek additional time to gather signatures.

A brief extension of the deadline is reasonable and will not prejudice any party. Accordingly, the deadline will be extended, and the schedule will be modified with respect to petitions to Intervene or Participate and any response thereto.

### **ORDER**

1. Any petitions to Intervene or Participate in the Public Hearing, pursuant to 310 CMR 16.20(9), shall be filed with the Board by **January 30, 2026**.
2. Any response to any petition to Intervene in the Public Hearing shall be filed with the Board by **February 3, 2026**.
3. The Hearing Officer will issue a ruling on any petition to Intervene in the Public Hearing by **February 6, 2026**.

4. The remaining deadlines set forth in the Prehearing Report and Order shall remain the same.
5. This Procedural Order shall be posted on the Board's webpage for this matter.
